3 **Ordinance authorizing settlement of the lawsuit filed by Francine Austin against the**  
4 **San Francisco Department of Public Health for \$90,000; the lawsuit was filed on**  
5 **November 4, 2020, in United States District Court for the Northern District of California,**  
6 **Case No. 20-CV-07803; entitled Francine Austin v. San Francisco Department of Public**  
7 **Health; the lawsuit involves an employment dispute.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Francine Austin v. City and County of  
12 San Francisco, United States District Court for the Northern District of California, Case  
13 No. 20-CV-07803 by the payment of \$90,000. The lawsuit involves an employment dispute.

15 Section 2. The above-named action was filed in United States District Court for the  
16 Northern District of California on November 4, 2020, and the following parties were named in  
17 the lawsuit: Plaintiff: Francine Austin; Defendant: San Francisco Department of Public Health
