3 **Resolution authorizing the Chief of Police for the City and County of San Francisco to**
4 **retroactively accept and expend a grant in the amount of \$98,280 from the Governor's**
5 **Office of Emergency Services for a program entitled Project Safe Neighborhood –**
6 **Operation Cease-Fire.**

8 WHEREAS, The Chief of Police of the City and County of San Francisco desires to
9 undertake a certain project designated "Project Safe Neighborhood – Operation Cease-Fire,
10 to be funded from funds made available through the Governor's Office of Emergency
11 Services; and,

12 WHEREAS, The Operation Cease-Fire program couples a narcotics "buy-bust"
13 Program with the U.S. Attorney's Triggerlock program in an effort to reduce both narcotics
14 trafficking and gun violence, thereby helping to also affect the homicide rate related to
15 narcotics activity; and,

16 WHEREAS, the grant does not require an ASO amendment; and,

17 WHEREAS, The grant terms prohibit including indirect costs in the grant budget; now,
18 therefore, be it

19 RESOLVED, That the Chief of Police for the City and County of San Francisco is
20 authorized on behalf of the City and County of San Francisco to retroactively accept and
21 expend continued funding for this project from the Governor's Office of Emergency Services;


23 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of
24 indirect costs in the grant budget; and be it

1 FURTHER RESOLVED, That The Chief of Police of the City and County of San
2 Francisco is authorized to execute on behalf of the City and County of San Francisco the
3 necessary Grant Agreement for this project including any extensions, funding augmentations
4 from the Governor's Office of Emergency Services, or amendments thereof; and be it

5 FURTHER RESOLVED, That it is agreed that any liability arising out of the
6 performance of this Grant Agreement, including civil court actions for damages, shall be the
7 responsibility of the grantee and the authorizing agency; and be it

8 FURTHER RESOLVED, That grant funds received hereunder shall not be used to
9 supplant expenditures controlled by the Board of Supervisors.


