2 Map - 800 Presidio Avenue]

4 **Motion: 1) making environmental findings and finding the Tentative Parcel Map for a 2-**  
5 **unit multi-use subdivision located at 800 Presidio Avenue, Assessor's Block No. 1073,**  
6 **Lot No. 013, consistent with the City's General Plan and eight priority policies of**  
7 **Planning Code Section 101.1; 2) approving the decision of the Department of Public**  
8 **Works; and 3) approving the Tentative Parcel Map.**

10 WHEREAS, The Planning Department found the subject Tentative Parcel Map in  
11 compliance with the California Environmental Quality Act (California Public Resources Code  
12 Sections 21000 et seq.) and found it consistent with the City's General Plan and priority policy  
13 findings of Planning Code Section 101.1. Said determination is on file with the Clerk of the  
14 Board of Supervisors in File No. 120660 and is incorporated herein by reference; and,

15 WHEREAS, The Department of Public Works, in a decision dated May 31, 2012,  
16 approved a Tentative Parcel Map for a 2-unit multi-use subdivision at 800 Presidio Avenue,  
17 Assessor's Block No. 1073, Lot No. 013. Said determination is on file with the Clerk of the  
18 Board of Supervisors in File No. 120660 and is incorporated herein by reference; and,

19 WHEREAS, On June 11, 2012, Stephen M. Williams, on behalf of Neighborhoods for  
20 Fair Planning, filed a timely appeal to the decision of the Department of Public Works; and,

21 WHEREAS, On July 10, 2012, this Board held a duly noticed public hearing to consider  
22 the appeal of the Tentative Parcel Map filed by Appellants; and,

23 WHEREAS, This Board has reviewed and considered the subject Map, the appeal  
24 letter, the other written records before the Board of Supervisors, and heard testimony and  
25 received public comment regarding the subject Map; now, therefore, be it
