



Amendment No. 3 TO THE 2007-2013 MEMORANDUM OF UNDERSTANDING BETWEEN

THE CITY AND COUNTY OF SAN FRANCISCO AND

THE MUNICIPAL EXECUTIVES' ASSOCIATION, FIRE



The parties hereby amend the Memorandum of Understanding as follows:

III.Q. HEALTH AND DENTAL INSURANCE

- 103. <u>Health Coverage</u>: The City shall provide contributions for employee health benefits at the rate prescribed in Charter Sections A8.423 through A8.428.
- The City shall contribute the greater amount of \$225 per month or 75% of the rate charged to employees for Kaiser coverage at the dependent plus two or more level, including any additional charges assessed to Health Service System members by vote of the Health Services Board, per covered employee towards the management cafeteria benefit program as provided under the agreement between the City and the MEA Miscellaneous MOU.
- Dental Insurance: The City agrees to maintain dental benefits at present levels for the duration of the agreement.
- Effective July 1, 2011, employees who enroll in the Delta Dental PPO Plan shall pay the following premiums for the respective coverage levels: \$5/month for employee-only, \$10/month for employee + 1 dependent, or \$15/month for employee + 2 or more dependents.
- The aforesaid contributions shall not be considered as a part of an employee's compensation for the purpose of computing straight time earnings or retirement benefits; nor shall such contributions be taken into account in determining the level of any other benefit which is a function of, or percentage of salary.
