2 SAN FRANCISCO TO ACCEPT AND EXPEND FUNDS IN THE AMOUNT OF

9 WHEREAS, the Chief of Police of the City and County of San Francisco desires
10 to undertake a certain project designated "Operation Revitalization-Ocean View/Merced
11 Heights/Ingleside" (herein after referred to as "Operation Revitalization-OMI") funded
12 from funds made available through the Office of Criminal Justice Planning
13 (herein after referred to as OCJP) for the suppression, intervention, and prevention of
14 crime in the Ocean View/Merced Heights/Ingleside District; now therefore be it

17 RESOLVED, that the Chief of Police of the City and County of San Francisco is
18 authorized to execute on behalf of the Board of Supervisors of the City and County of
19 San Francisco the attached Grant Award Agreement including any extensions or
20 Amendments therefore; and be it


22 FURTHER RESOLVED, that it is agreed that any liability arising out of the
23 performance of this Grant Award Agreement, including civil court actions for damages,
24 shall be the responsibility of the grantee and the authorizing agency. The State of
25 California and OCJP disclaim responsibility for and such liability; and be it


1 FURTHER RESOLVED, that the Board of Supervisors hereby waive indirect costs,
2 and be it

3 FURTHER RESOLVED, that grant funds received hereunder shall not be used to
4 supplant expenditures controlled by this body; and be it

6 FURTHER RESOLVED, that the Chief of Police of the City and County of San
7 Francisco is authorized to accept, and expend in the amount of THREE HUNDRED
8 SEVENTY THOUSAND-EIGHT HUNDRED DOLLARS (\$370,800.00) made available
9 through the Office of Criminal Justice for the project known as "Operation
10 Revitalization-OMI."; and be it


