3 **Resolution approving the settlement of the unlitigated claim filed by International**
4 **Federation of Professional and Technical Engineers, Local 21, AFL-CIO (“Local 21”)**
5 **and Marco Magallon against the City and County of San Francisco for \$229,000; the**
6 **claim was filed on April 7, 2023; the claim involves an employment grievance under the**
7 **Memorandum of Understanding between the City and County of San Francisco and**
8 **Local 21; additional material term of the settlement is the adjustment of Marco**
9 **Magallon’s termination date.**

11 WHEREAS, International Federation of Professional and Technical Engineers, Local
12 21, AFL-CIO (“Local 21”) Local 21 filed a claim on April 7, 2023, against the City and County
13 of San Francisco; and

14 WHEREAS, The claim involves an employment grievance under the Memorandum of
15 Understanding between the City and County of San Francisco and Local 21; and

16 WHEREAS, Department of Human Resources has recommended settlement of the
17 claim by payment of \$229,000 and adjustment of Marco Magallon’s termination date; now,
18 therefore, be it

19 RESOLVED, That pursuant to Administrative Code, Section 10.22, the Board of
20 Supervisors hereby authorizes the City Attorney to settle and compromise the claim by
21 payment of \$229,000 and adjustment of Marco Magallon’s termination date.
