10 Meuron have attracted critical praise for their architectural work around the world, and have  
11 designed a wide variety of buildings and structures, including museums, residences,  
12 apartment buildings, libraries, schools and office buildings; and,

13 WHEREAS, Other Herzog & de Meuron projects include London's recently opened  
14 Tate Modern Bankside, Napa Valley's Dominus Winery, the Goetz Collection gallery in  
15 Munich and numerous other public and private buildings in both the United States and  
16 Europe; and,

17 WHEREAS, The award of the Pritzker Prize to Herzog & de Meuron assures that the  
18 New de Young will bring to San Francisco a museum building of world-class quality and  
19 reputation; now, therefore, be it






