FURTHER RESOLVED, That the Mayor of the City and County of San Francisco is authorized to execute on behalf of the Board of Supervisors of the City and County of San Francisco the Grant Award

Agreement, adhering to the requirements and conditions specified by the Department of Justice, including any extensions, amendments thereof; and be it

FURTHER RESOLVED, That it is agreed any liability arising out of the performance of this Grant Award Agreement, including civil court actions for damages, shall be the responsibility of the grantee and the authorizing agency. The United States Government and the Department of Justice disclaim responsibility for any such liability; and be it

FURTHER RESOLVED, That the Board of Supervisors authorizes the Mayor of the City and County of San Francisco to apply for retroactively, accept and expend a grant in the amount of Two hundred Thousand dollars (\$200,000.00) from the U.S. Department of Justice - Office of Justice Programs to administer the "State and Local Domestic Preparedness Equipment Support Program."
