Resolution supporting the appointment of Sonoma County Supervisor Lynda Hopkins as the California Coastal Commission North Central Region Representative.

WHEREAS, Sonoma County Supervisor Lynda Hopkins was elected to the Sonoma County Board of Supervisors in 2016 as the District 5 representative, and serves as the Chair of Sonoma Clean Power, Chair of the Regional Climate Protection Authority and Sonoma County Transportation Authority, and Vice Chair of the Bay Area Air Quality Management District; and

WHEREAS, Supervisor Hopkins earned a Bachelor of Science Degree through the Ocean Track of the Earth Systems Program at Stanford University, studying coastal land use and environmental sciences, and earned a graduate degree from Stanford University focusing on mass transit, land use policy, and the communications of these issues to the public; and

WHEREAS, Supervisor Hopkins has been a dedicated advocate for the protection and public access of our coastal resources, natural habitats, and open spaces; and

WHEREAS, Supervisor Hopkins led the effort to bring Sonoma County's Local Coastal Plan Update forward to the Coastal Commission, and through the process, prioritized public access, affordable housing, climate resilience, marine ecosystem restoration, sea otter reintroduction, and managed retreat, ultimately securing unanimous approval of the Sonoma County Board of Supervisors; and

WHEREAS, Supervisor Hopkins formed the Sonoma Coast's first-ever Municipal Advisory Council comprised of nine representatives of the Sonoma Coast's unincorporated communities, including tribal representation; and

WHEREAS, Supervisor Hopkins led multiple efforts to acquire coastal lands for protection and parks, and partnered with Caltrans and the Coastal Commission on the Gleason Beach Highway 1 Realignment Project; now, therefore, be it

RESOLVED, That the Board of Supervisors of the City and County of San Francisco hereby support the appointment of Sonoma County Supervisor Lynda Hopkins for consideration for the North Coast Central seat on the California Coastal Commission, based on her successful track record protecting coastal lands, balancing the public's access to coastal areas, and representing the best interests of stakeholders from throughout the North Central coastal zone; and, be it

FURTHER RESOLVED, That, upon final adoption of this resolution, the Clerk of the Board of Supervisors is directed to transmit a copy to the Chairperson and members of the California Senate Rules Committee.
