5 **year extensions of Federal and State grants expiring on June 30, 2004.**

6 WHEREAS, With the budget shortfalls the State is facing, the Administration and the  
7 Legislature are requiring improved management of Federal and State funds; and

8 WHEREAS, The Department of Public Works received \$1,317,000 in Federal grant  
9 funds to construct curb ramps throughout the City; and,

10 WHEREAS, The Department of Public Works received \$154,172 in State Seismic  
11 funds and \$1,275,228 in Federal Seismic and Federal Highway Bridge Replacement and  
12 Rehabilitation program funds for the preliminary engineering phase of the Fourth Street Bridge  
13 seismic retrofit and rehabilitation project; and,

14 WHEREAS, The Federal and State funds for these projects expire on June 30, 2004;  
15 and,

16 WHEREAS, State Department of Finance requires that the Department of Public Works  
17 bill for unspent Federal and State funds for these projects by May 1, 2004 unless the  
18 Department of Public Works requests a funding extension by December 1, 2003; and,

19 WHEREAS, The Department of Public Works requires a funding extension of because  
20 the projects are expected to go beyond the May 1, 2004 deadline; and

21 WHEREAS, The State Department of Finance requires a resolution be approved by the  
22 local governing body indicating their concurrence with the Department of Public Works'  
23 request for a one-year extension of the Federal and State grants; and,






