Dear GAO Committee,

I have received through various means the attached public records now in my possession.

Either Mayor London Breed [lied in her signed writing to the GAO Committee on October 3, 2022](#) (Breed writes to you they "had been requested from **some** appointees" (emphasis mine); further confirmed by Elsbernd during the hearing that they were only on a case by case basis); or the Mayor lied through Director Tyra Fennell at least (a) to Rent Board appointee Kion Sawney [on Sept 13, 2021](#) to induce Sawney to sign the resignation letter stating "The attached (and below in the body of this email) is a resignation letter, which is **standard for all of our Commission appointments** in case there is some kind of emergency. **Again, this is a standard practice we ask of all of our Commissioners**" (emphasis in original), and (b) to Airport Commissioner Jane Natoli [on Sept 7, 2021](#) to attempt to induce Natoli to sign the resignation letter stating "**Again, this is a standard practice we ask of all of our Commissioners.**" (emphasis in original).

**Moreover, in at least the case of Sawney, this lie appears to have induced Sawney to sign the letter.** In the case of Natoli apparently the draft letter was not signed.

The Committee should further demand all communications within the Mayor's Office *and within all commissions* to which the Mayor makes appointments regarding requesting, drafting, and receiving these undated resignation letters to investigate for itself the lies by Mayor Breed. The Mayor may not completely respond to your information request, while the commissioners themselves may provide more.

The BoS should further investigate under Charter Section 16.114 the extent to which Mayor Breed and her office have misled either the BoS or other public officials about this issue, and if the Mayor or her staff has violated any civil or criminal laws or engaged in official misconduct, and make all appropriate referrals for investigation.

Please find below and enclosed our response to the questions contained in your September 27<sup>th</sup>, 2022 Letter of Inquiry. We have also enclosed additional resignation letters, and corresponding retraction letters for any currently serving commissioners, which were located after searching additional electronic and hard copy records in our office. To aid in answering some of these questions you will also find attached a summary list of the resignation letters we have received, the date received if known, and their status.

**Commissions:**

- 2- 3. No resignation letters were required. The Mayor takes the responsibility of serving the City and County of San Francisco seriously and expects all commissioners to do so as well. The letters of resignation - which had been requested from some appointees - were representative of that commitment and reserved for the most dire situations of inappropriate behavior, incapacitation, or dereliction of duties.
- 4-5. According to our records we have received 48.
6. Copies were provided to the full Board of Supervisors on September 27, 2022 and additional names and documents are enclosed herein.
7. Copies of these documents were provided to the full Board of Supervisors on September 27, 2022 and additional names and documents are enclosed herein. Copies of Commission related materials and resignation letters exist in electronic copy on a shared drive in our office as well as in hard copy files in our office. Therefore, several staff have access to them. Our office does not have the precise date of transmittal for each of these letters, however, where available, we have noted those dates in the attached list.

**Elected Office Vacancies:**

- 8-11. The Mayor has never required an undated resignation letter from any appointee, including an appointee to a vacant elected position and the positions referenced in question 9. As such, we have no documents or information responsive to questions 10 and 11.

15. Resignation letters have never been required as a condition of appointment.
16. Copies of Commission related materials and resignation letters exist in electronic copy on a shared drive in our office as well as in hard copy files in our office. Therefore, several staff have access to them.
17. The Mayor has consulted with the City Attorney's Office and been informed that, while not a violation of the Charter, the letters are likely unenforceable in court if they were ever to be used and challenged. The Mayor will still hold her commissioners accountable to the standards behind the intent of the letters, but will discontinue the practice of requesting the letters and existing letters for current commissioners have been rescinded.

20. Some appointees have not provided them for a variety of reasons, not all of which we have knowledge of or can speculate about. Some reasons have included overlooking the request and inability to open or transmit the signed document electronically. These include Rachel Tanner, appointee to the Planning Commission, Jane Natoli, appointee to the Airport Commission, Jason Wright, appointee to the Historic Preservation Commission, and Manny Yekutiel, appointee to the Municipal Transportation Agency Board. In no instance did this prevent those individuals from moving forward with their nomination or appointment.

We have also enclosed additional resignation letters, and corresponding retraction letters for any currently serving commissioners, which were located after searching additional electronic and hard copy records in our office. To aid in answering some of these questions you will also find attached a summary list of the resignation letters we have received, the date received if known, and their status.

The Mayor has consulted with the City Attorney's Office and been informed that, while not a violation of the Charter, the letters are likely unenforceable in court if they were ever to be used and challenged. The Mayor will still hold her commissioners accountable to the standards behind the intent of the letters, but will discontinue the practice of requesting the letters and existing letters for current commissioners have been rescinded.

20. Some appointees have not provided them for a variety of reasons, not all of which we have knowledge of or can speculate about. Some reasons have included overlooking the request and inability to open or transmit the signed document electronically. These include Rachel Tanner, appointee to the Planning Commission, Jane Natoli, appointee to the Airport Commission, Jason Wright, appointee to the Historic Preservation Commission, and Manny Yekutiel, appointee to the Municipal Transportation Agency Board. In no instance did this prevent those individuals from moving forward with their nomination or appointment.

Dear Mayor Breed:

This Letter of Inquiry concerns your requests for appointees/nominees to sign undated resignation letters at a time when the appointee/nominee is not seeking to resign and when you are not seeking their actual resignation. Your office has now publicly acknowledged obtaining such letters from Police Commissioner Max Carter-Oberstone and an unspecified number of other mayoral-appointed commissioners. My office is concerned that these resignation letters threaten the independence of appointees and undermine and/or violate the City's Charter.

The purpose of this Letter of Inquiry is not to debate the propriety of such advance undated resignation letters. Instead, the purpose is to gather the facts related to the recent allegations and practices. We request responses to each of the following questions:

### **Commissions**

1. Has the Mayor required any mayoral appointees ("appointee" in each of these requests shall include a nominee for an appointed position) to any commission to provide an undated resignation letter to the Mayor or her representatives?
2. Why were undated resignation letters required of these appointees?
3. Prior to September 23, 2022, what was the Mayor's policy and practice with respect to requiring undated resignation letters from nominated/appointed commissioners?
4. How many undated resignation letters from appointed commissioners has your office received from appointed commissioners since Mayor Breed took office?
5. How many undated resignation letters from Commissioners is your office currently in possession of, whether in writing or electronically?
6. Identify and list each and every current commissioner who has transmitted an undated Resignation Letter to the Mayor, the Mayor's Office, or anyone acting on behalf of the Mayor.

7. For each undated resignation letter in response to the previous question, state the name of the commissioner, their position, the date on which the Mayor's Office received the signed letter, the person in the Mayor's Office to whom it was transmitted, and the person or persons with current access to the document.

10. Identify each and every appointee to a vacant elected position who has transmitted an undated Resignation Letter to the Mayor, the Mayor's Office, or anyone acting on behalf of the Mayor.
11. For each undated resignation letter obtained from an appointee to a vacant elected position, state and list the name of the appointee, their position, the date on which the Mayor's Office received the signed letter, the person in the Mayor's Office to whom it was transmitted, and the person or persons with current access to the document.

12. Please identify any appointees to any other board, not referenced above, including any task force, working group, commission, committee, or appointed body, from whom you requested or required an undated resignation letter at any time since Mayor Breed took office.

14. Did the Mayor's office request Commissioner Carter-Oberstone to submit a signed, undated letter of resignation during his initial appointment to the Police Commission for the unexpired portion of a four-year term that ended on April 30, 2022, to the seat formerly held by Commissioner Dion-Jay Brookter?
