5 vehicles are hereby enacted or rescinded as designated below:

8 **DIAMOND (BUSES AND LEFT TURNS ONLY) LANE - ESTABLISH**

9 4th Street, east curb lane, between Harrison and Brannan Streets (#1 southbound  
10 traffic lane)

11 4th Street, second lane from east curb, between Brannan and Townsend Streets  
(#2 southbound traffic lane)

12 **TOW-AWAY, NO STOPPING, 7 AM - 7 PM, MONDAY THROUGH FRIDAY - ESTABLISH**

13 4th Street, east side, between Brannan and Freelon Streets

14 4th Street, east side, between Bryant and Stillman Streets




