4 **Motion directing the Clerk of the Board to prepare a request for qualifications to enable**
5 **a radio station to broadcast weekly San Francisco Board of Supervisors meetings for**
6 **an amount not to exceed \$150,000.**

8 WHEREAS, The Board of Supervisors values open government and San Franciscans'
9 civic engagement; and

10 WHEREAS, Currently, members of the public may only follow the proceedings of the
11 Board of Supervisors by attending meetings in person, utilizing cable television, or through the
12 internet; and

13 WHEREAS, Radio is a free and accessible medium that promotes public access to the
14 government's work; and

15 WHEREAS, Meetings of the Board of Supervisors were previously broadcast on the
16 radio, most recently by KPOO; now, therefore, be it

17 MOVED, That this Board directs the Clerk of the Board to prepare a request for
18 qualifications to enable a radio station to broadcast weekly San Francisco Board of
19 Supervisors meetings and to implement the plan for such broadcasts for an amount not to
20 exceed \$150,000 and that stations with community-oriented programming and prior
21 experience airing government meetings.
