Resolution authorizing the Department of Public Health, Community Substance Abuse Services and Housing and Urban Health, to accept retroactively and expend first year grant funds of \$496,520 from the Center for Substance Abuse Treatment (CSAT) for Action Point-II HIV Treatment Capacity Expansion and to enter into an agreement which includes a rights in data clause, for the use of these funds; providing for ratification of action previously taken.

WHEREAS, The Department of Public Health has applied for and been awarded a three year grant from CSAT in the amount of \$496,520 for the first year for a medication adherence support program that assists HIV infected urban poor to adhere to antiretroviral medications; and,

WHEREAS, As a condition of receiving the grant funds, CSAT requires the City to enter into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the Board of Supervisors in File No. 002093, which is hereby declared to be a part of this resolution as if set forth fully herein; and,

WHEREAS, The Agreement contains a certain provision described below, which requires the approval of the Board of Supervisors; and,

WHEREAS, The grant budget includes provision for indirect costs of \$12,110; now, therefore, be it

6 FURTHER RESOLVED, That the Board of Supervisors hereby approves the
7 provision in the Agreement pursuant to which the City agrees to grant a royalty-free,
8 nonexclusive, and irrevocable license for the use of data developed under the grant;
9 and, be it


10 FURTHER RESOLVED, That the Board of Supervisors authorizes the Director
11 of Health to enter into similar agreements with CSAT if the grant recurs or is
12 renewed; and, be it


13 FURTHER RESOLVED, That the Controller should be urged to designate the

15 terminate when the grant expires.






