2 its decision on a proposed ordinance that would amend the Planning Code to create the  
3 Fringe Financial Service Restricted Use District and make related Zoning Map amendments]

4 **Resolution extending by 30 days the prescribed time within which the Planning**  
5 **Commission may render its decision on a proposed ordinance that would amend the**  
6 **Planning Code to create the Fringe Financial Service Restricted Use District**  
7 **and make related Zoning Map amendments.**

9 WHEREAS, On May 15, 2007, Supervisor Ammiano introduced legislation to initiate  
10 the process amending San Francisco Planning Code Sections 249.5, 781.8, 781.9, 782, and  
11 783 and adding Section 249.35 to the San Francisco Planning Code to create a  
12 noncontiguous Fringe Financial Service Restricted Use District prohibiting new fringe financial  
13 services, as defined, with certain exceptions; amending San Francisco Planning Code  
14 Section 312 to require certain notice in Neighborhood Commercial Districts; amending San  
15 Francisco Planning Code Section 227 to add Fringe Financial Service Use to the Commercial  
16 District Zoning Control Table; amending San Francisco Planning Code Sections 702.4 and  
17 710 through 730 to add Fringe Financial Service Use to the Neighborhood Commercial  
18 District Zoning Control Tables; adding Section 790.111 and 890.113 to the San Francisco  
19 Planning Code to define a Fringe Financial Service Use; amending San Francisco Planning  
20 Code Sections 790.110, 790.112, 890.110, and 890.112 to require that use applications for  
21 Financial Services and Limited Financial Services include a copy of any state-issued license;  
22 amending San Francisco Planning Code Sections 803.2, 810, 811, and 812 to add Fringe  
23 Financial Service Use to the Chinatown Zoning Control Tables; amending San Francisco  
24 Planning Code Sections 814 through 818 to add Fringe Financial Service Use to certain  
25 Zoning Control Tables in the South of Market area; amending San Francisco Planning Code

1 Section 827 to add Fringe Financial Service Use to the Rincon Hill Downtown Residential  
2 Mixed Use District Zoning Control Table; amending Sections 909, 910, 911, 912, 913, and  
3 914 to add Fringe Financial Service Use to certain Mission Bay Zoning Control Tables;  
4 amending Sectional Maps Numbers 1SU, 2SU, 6SU, 7SU, 8SU, and 10SU of Zoning Map of  
5 the City and County of San Francisco to indicate the boundaries of the Fringe Supervisor  
6 Ammiano and City Treasurer Financial Service Restricted Use District, and making findings,  
7 including environmental findings and findings of consistency with the priority policies of  
8 Planning Code Section 101.1 and the General Plan; and

9 WHEREAS, A copy of said legislation is on file with the Clerk of the Board of  
10 Supervisors in File No. 070671 and is incorporated herein by reference; and,

11 WHEREAS, The Board, in accordance with Planning Code Section 306.4(d) may, by  
12 resolution, extend the prescribed time within which the Planning Commission is to render its  
13 decision on proposed amendments to the Planning Code that the Board of Supervisors  
14 initiates; and,

15 WHEREAS, The Planning Department has requested additional time to review the  
16 proposed ordinance, and the Board deems it appropriate in this instance to grant to the  
17 Planning Commission additional time to review the proposed ordinance and render its  
18 decision; now; now, therefore, be it

19 RESOLVED, That by this resolution, the Board hereby extends the prescribed time within  
20 which the Planning Commission may render its decision on the proposed ordinance for an  
21 additional 30 days.
