13 **SEC. 7.4-1. REPORTS TO DISASTER COUNCIL.**

14 Following any declared emergency, activation of the City's Emergency Operations Center, or  
15 credible disaster warning, the Office of Emergency Services shall submit a written report to the  
16 Disaster Council and the Board of Supervisors describing and evaluating the City's response.


