<b>NATURE OF THE CONTRACT (Please describe)</b> <p>In 2016, the SFMTA executed Contract No. 2014-48 with San Francisco AutoReturn for towing and storage of abandoned and illegally parked vehicles. The Board of Supervisors approved the five year base term of the agreement in an amount not to exceed \$65.4million and authorized the Director of Transportation to extend the agreement for five additional years under his own authority.</p> <p>Funding for the extension years was not requested at the time of contract award, and it now needed to fund the extension. To give the SFMTA time to assess how the pandemic has affected tow program costs and to re-evaluate tow program policies and funding needs as the City emerges from pandemic conditions, the funding request is for the first two years of the extension for \$22,8 million, and a total not to exceed of \$88.2 million.</p>
