9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Findings.

11 WHEREAS, Section 15.17 of the San Francisco Administrative Code established a
12 “Drug Abuse Advisory Board” and Section 15.19 of the San Francisco Administrative Code
13 established a “City-Wide Alcoholism Advisory Board”; and

14 WHEREAS, Rule 2.27 of the Board of Supervisors' Rules of Order requires the Clerk of
15 the Board to determine and identify each year every subordinate body that has not met for at
16 least four months and to request the City Attorney to prepare legislation repealing the
17 resolution or ordinance that created the body; and

18 WHEREAS, The Clerk of the Board polled both of these subordinate bodies to
19 determine whether they had met in the last four months and determined that the Drug Abuse
20 Advisory Board was not responsive and the City-Wide Alcoholism Advisory Board had not met
21 in the last five months.
