3 Ordinance authorizing settlement of the portion of the lawsuit filed by Sally Seid  
4 against the City and County of San Francisco for \$27,815; the lawsuit was filed on  
5 January 31, 2005, in San Francisco Superior Court, Case No. 436930; entitled Jane  
6 Martin, et al. v. City and County of San Francisco, et al.

7 Be it ordained by the People of the City and County of San Francisco:

8 Section 1. The City Attorney is hereby authorized to settle the portion of the action  
9 entitled "Jane Martin, et al. v. City and County of San Francisco, et al." San Francisco  
10 Superior Court, Court No. 436930, as it relates only to plaintiff Sally Seid, by the payment of  
11 \$27,815, representing the claim for diminution of property value, and excluding attorney's  
12 fees, costs and interest, which will be addressed in later proceedings.

13 Section 2. The above-named action was filed in San Francisco Superior Court on  
14 January 31, 2005, and the following settling parties were named in the lawsuit: Plaintiff Sally  
15 Seid and Defendant City and County of San Francisco.
