Resolution supporting California Bicycle Commute Week May 12-16, 2003

WHEREAS. Forty percent of Bay Area commuters, approximately 1,000,000 people, live five miles or less from their work site—an ideal distance for bicycle commuting; and WHEREAS. If every Bay Area solo driver living within five miles of his/her office biked on Bike to Work Day there would be over 600,000 fewer vehicles on the road, keeping more than 100 tons of pollution out of the Bay Area's air; and,

WHEREAS, Hundreds of thousands of Bay Area residents live near transit, linking cyclists and pedestrians with transit, as called for by BART and the toll expenditure plan's "Safe Routes to Transit," which provides secure parking for cyclists and safe transit access for pedestrians and cyclists throughout the Bay Area; and,

WHEREAS, Bicycle transportation is an integral part of the multi-modal transportation system planned for by federal, state, regional, and local transportation government agencies; and, WHEREAS. The Bicycle industry is a strong supporter of Bike Commute Week and a key contributor to California's economy, providing thousands of jobs and promoting more bicyclefriendly cities; and,

WHEREAS, A 1999 Bike to Work Day survey has shown that nearly forty percent of those who participated in Bike to Work Day were first time bike commuters, and of those, thirty-two percent have continued to bike to work since the event; and

| WHEREAS, Bike Commute Week has incredible potential to increase bicycle commuting in |

| WHEREAS, The California Bicycle Coalition, the American Lung Association of California, the |

| WHEREAS, The month of May is National Bike Month to promote the bicycle as a means of |
| transportation and recreation; and, |
| WHEREAS, On Thursday May 15, 2003, tens of thousands of Bay Area residents are |
| expected to bicycle on Bike to Work Day, and over one hundred Energizer Stations and many |
| other supportive events will occur to promote bicycle commuting in the Bay Area; and, |
| WHEREAS, The City and County of San Francisco is currently engaged in the update of the |
| Citywide Bicycle Plan, intended to create a network of bicycle friendly streets and pathways |
| throughout the City; now, therefore, be it |

| Week and encourages all residents to take the healthy commute and bike to work, school, or |
