3 **Resolution determining that the issuance of a Type 42 on-sale beer and wine**  
4 **public premises license to Justin Beem and Daniel Brooker for Resolute Drinks,**  
5 **LLC, dba Resolute, located at 678 Geary Street (District 3), will serve the public**  
6 **convenience or necessity of the City and County of San Francisco, in accordance**  
7 **with California Business and Professions Code, Section 23958.4, and**  
8 **recommending that the California Department of Alcoholic Beverage Control**  
9 **impose conditions on the issuance of the license.**

11 WHEREAS, Justin Beem and Daniel Brooker are seeking the issuance of a Type  
12 42 on-sale beer and wine license for Resolute Drinks, LLC, dba Resolute, located at  
13 678 Geary Street; and,

14 WHEREAS, The Planning Department has verified that the area is properly  
15 zoned and recommends approval; and,

16 WHEREAS, The Police Department has filed two (2) protests with the  
17 Department of Alcoholic Beverage Control under California Business and Professions  
18 Code, Section 24013, and recommends that the Department of Alcoholic Beverage  
19 Control issue the liquor license with conditions; and

20 WHEREAS, The conditions recommended by the Police Department are the  
21 following: 1) Sales, service and consumption of alcoholic beverages shall be permitted  
22 from 12 p.m. until 12 a.m. (midnight) Sunday thru Thursday and from 12 p.m. until 2:00  
23 a.m. Friday thru Saturday (with the exception of the New Year's Eve holiday, then  
24 Resolute may be allowed to sell and service alcoholic beverages until 2 a.m.); 2) The  
25 sale of beer beverages for off-sale consumption is strictly prohibited; 3) No noise

1 shall be audible beyond the area under the control of the licensee as defined on the  
2 ABC-257; 4) The petitioner(s) shall be responsible for maintaining free of litter the area  
3 adjacent to the premises over which they have control; 5) Loitering (defined as “to  
4 stand idly about; linger aimlessly without lawful business”) is prohibited on any  
5 sidewalks or property adjacent to the licensed premises under the control of the  
6 licensee as depicted on the ABC-257; 6) Graffiti shall be removed from the premises  
7 and all parking lots under the control of the licensee within 72 hours of application. If  
8 the graffiti occurs on a Friday or weekend day, or on a holiday, the licensee shall  
9 remove the graffiti with 72 hours following the beginning of the next week day; 7) The  
10 interior lighting maintained therein shall be sufficient to make easily the discernable  
11 appearance and conduct of all persons and patrons in that portion of the premises  
12 where alcoholic beverages are sold, served, delivered or consumed. At no time shall the  
13 occupancy of the premise exceed the established lawful limit set by the San Francisco  
14 Fire Department; 8) The exterior of the premises shall be equipped with lighting of  
15 sufficient power to illuminate and make easily discernible the appearance and conduct  
16 of all persons on or about the premises. Additionally, the position of such lighting shall  
17 not disturb the normal privacy and use of any neighboring residences; now, therefore,  
18 be it

19           RESOLVED, That in accordance with California Business and Professions Code,  
20 Section 23958.4, the Board of Supervisors of the City and County of San Francisco  
21 hereby determines that the issuance of a Type 42 on-sale beer and wine license to  
22 Justin Beem and Daniel Brooker for Resolute Drinks, LLC, dba Resolute, located at 678  
23 Geary Street, will serve the public convenience or necessity of the City and County of  
24 San Francisco; and, be it

1           FURTHER RESOLVED, That the Board of Supervisors of the City and County of  
2 San Francisco hereby endorses and adopts the recommendations of the Police  
3 Department listed above, and recommends that the Department of Alcoholic Beverage  
4 Control issue the license with those conditions.


