9 WHEREAS, On January 30, 2020, the Service Employees International Union, Local
10 1021 (“Union”) filed a claim against the City and County of San Francisco on behalf of a class
11 of 2320 Registered Nurses and 2328 Nurse Practitioners; and

12 WHEREAS, The claim involves a labor dispute concerning back pay; and

13 WHEREAS, The Department of Public Health has recommended settlement of the
14 claim by payment of a total of \$236,895.29 to the members of the class; now, therefore, be it

15 RESOLVED, That pursuant to Administrative Code, Section 10.22, the Board of
16 Supervisors hereby authorizes the City Attorney to settle and compromise the claim by
17 payment of \$236,895.29.
