13 Northeast Committee, the Rincon Point/South Beach Committee, the Ferry Building
14 Committee, the Broadway Development Committee, the Waterfront/Land Use Plan/Urban
15 Design Technical Committee, the Pier 45 Committee, the Pier 70 Committee, the Bryant
16 Street Pier Committee, the Environmental Quality Advisory Committee and the Waterfront/Land Use Committee; and

17 WHEREAS, The membership of these Citizen Advisory Committees includes a broad
18 spectrum of waterfront stakeholders; and

19 WHEREAS, The San Francisco Port Commission is currently considering a number of
20 proposals regarding development of the San Francisco waterfront; and

21 WHEREAS, The proposals and recommendations of the Citizen Advisory Committees
22 provides the Port Commission with well informed, practical input; now, therefore, be it

23 **RESOLVED**, That the Board of Supervisors urges the San Francisco Port Commission




