9 Be it ordained by the People of the City and County of San Francisco:


10 Section 1. The City Attorney is hereby authorized to settle the action entitled Yvette
11 Castillo v. San Francisco General Hospital, City and County of San Francisco, San Francisco
12 Superior Court, Case No. 416346 by the payment of \$96,400 and credit to Yvette Castillo of
13 twelve (12) days of vacation, subject to the requirement that Yvette Castillo will neither apply
14 for nor accept any clinical position in perioperative services for the City and County of San
15 Francisco at any time after July 1, 2004. In the event that civil service bumping would result in
16 reinstatement of Castillo to her previous 2310 Surgical Procedures Technician position (a
17 position she cannot accept), she will enter the City's reasonable accommodation process
18 based on the salary grade of the 2310 (step five) position.

19 Section 2. The above-named action was filed in San Francisco Superior Court on April
20 30, 2003, and the following parties were named in the lawsuit: Yvette Castillo, plaintiff; San
21 Francisco General Hospital and City and County of San Francisco, defendants.


