10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled **Martine Aniel v. City and County of**
12 **San Francisco et al**, San Francisco Superior Court, Case No. **CGC-24-612542** by the
13 payment of \$45,000. The lawsuit involves **alleged personal injury on a City sidewalk.**
