8 years, were subjected to severe persecution by the Turkish government of the Ottoman
9 Empire before and after the turn of the twentieth century, including widespread massacres,
10 usurpation of land and property, and destruction of cultural institutions and monuments during
11 the period from 1894 to 1896, and again in 1909; and

12 WHEREAS, The unspeakable horrors experienced by the Armenian people at the
13 hands of the Ottoman Turkish government culminated in 1915 in what is now known as the
14 Armenian Genocide; and

15 WHEREAS, From 1915 to 1923, Turkish authorities orchestrated and carried out a
16 genocide against the Armenian people - one of the world's oldest civilizations, with over
17 3,500 years in its ancestral homeland resulting in the deaths of approximately 1.5 million
18 Armenian women, men, and children, the loss of more than half of the Armenian population
19 in that homeland, and the widespread seizure or destruction of their personal and communal
20 property; and

21 WHEREAS, The U.S. House of Representatives adopted House Resolution No. 296
22 (Schiff) on October 29, 2019, which states it is U.S. policy to commemorate the Armenian
23 Genocide and the US Senate passed Senate Resolution No. 150 (Menendez) on December
24 12, 2019, which formally recognizes and affirms the historical facts of the Armenian Genocide
25 on behalf of the U.S. government and calls for broader education on this heinous crime and its
