

[Concurring with the Airport Commission Declaration of Emergency Contract Pursuant to Section 21.15 of the San Francisco Administration Code and approving the contract between the Airport Commission and Primeflight Aviation Services, Inc. in response to the Transportation Security Agency's Security Directive 1542-06-01B.]

Resolution concurring with the Airport Commission's Declaration of Emergency in response to the Transportation Security Administration's Security Directive 1542-06-01B requiring immediate additional screening of materials in the sterile areas of the Airport and approving the contract between the Airport Commission and Primeflight Aviation Services, Inc.

WHEREAS, On August 16, 2006, the Transportation Security Administration ("TSA") issued Security Directive ("SD") 1542-06-01B which required airport operators to conduct inspections of all food, beverage and merchandise products brought from the aircraft ramp area into sterile areas (post-security); and

WHEREAS, SD 1542-06-01B placed responsibility on the airport operator to conduct these inspections immediately; and,

WHEREAS, Pursuant to Section 21.15 of the San Francisco Administrative Code, on August 23, 2006 the Airport requested approval to enter into an emergency contract with Primeflight Aviation Services, Inc. in an amount not-to-exceed \$375,000;

WHEREAS, Approval to enter into the Primeflight contract was originally granted by the President of the Airport Commission, and on September 19, 2006, pursuant to Resolution No. No. 06-0180, the Airport Commission approved the Primeflight Aviation Services, Inc. contract on file with the Clerk of the Board of Supervisors in File No. 070298, which is hereby declared to be part of this resolution as if set forth fully herein; now, therefore, be it




