

1 [Disapproving the categorical exemption issued for the 2655 Scott Street project.]

3 **Motion disapproving the determination by the Planning Department that the 2655 Scott**  
4 **Street project is categorically exempt from environmental review under the California**  
5 **Environmental Quality Act.**

7 WHEREAS, for a proposal to add a vertical addition (partial 4<sup>th</sup> floor) and fire escapes  
8 to a single-family residence at 2655 Scott Street (the "Project"), the Planning Department  
9 included a determination of exemption from the California Environmental Quality Act in a staff  
10 report for a July 24, 2008, discretionary review hearing and stamped the site permit as  
11 categorically exempt from environmental review on September 16, 2008 (the "determination").  
12 A copy of said documents are on file with the Clerk of the Board of Supervisors in File No.  
13 081432, and are incorporated by reference herein; and,

14 WHEREAS, By letter to the Clerk of the Board of Supervisors dated November 10,  
15 2008, Stephen M. Williams, on behalf of Thomas and Annabel Yasuda, filed an appeal of the  
16 determination to the Board of Supervisors, which the Clerk of the Board of Supervisors  
17 received on or around November 10, 2008; and,

18 WHEREAS, On December 16, 2008, this Board held a duly noticed public hearing to  
19 consider the appeal of the determination; and,

20 WHEREAS, This Board has reviewed and considered the determination, the appeal  
21 letter, the responses to concerns document that the Planning Department prepared, and  
22 public testimony; and,

23 WHEREAS, The determination files and all correspondence and other documents have  
24 been made available for review by this Board and the public. These files are available for  
25

1 public review by appointment at the Planning Department offices at 1660 Mission Street, and  
2 are part of the record before this Board by reference herein; now, therefore, be it

3           Moved, That this Board of Supervisors disapproves the determination by the Planning  
4 Department that the Project is exempt/excluded from environmental review.
