9 WHEREAS, DPH applied for and was awarded a grant in the amount of \$787,659 from
10 the Department of Health and Human Services (DHHS), Public Health Service, with funding
11 from the federal Office of the Assistant Secretary of Preparedness and Response (ASPR), for
12 year 1 of the Healthcare Facilities Partnership Program for the period of September 1, 2007,
13 through August 8, 2008; and,

14 WHEREAS, This grant allows the City and County of San Francisco to increase
15 community and medical facility emergency preparedness systems for a response to
16 bioterrorism, other outbreaks of infectious disease and other public health threats and
17 emergencies; and,

18 WHEREAS, a copy of the Notice of Grant Award (NGA) is on file with the Clerk of the
19 Board of Supervisors in File No. 071516; which is hereby declared to be a part of
20 this resolution as if set forth fully herein; and,

21 WHEREAS, the grant does not require an ASO amendment and reimburses the
22 department for an existing Health Program Planner position (Job Class 2818) at 1.00 FTE
23 from September 1, 2006 through August 31, 2007; and,

24 WHEREAS, Resolutions authorizing the acceptance and expenditure of grant funds
25 may be placed automatically on consent agendas in committee, as they are usually


1 considered to be routine items, and this resolution authorizes the acceptance and expenditure
