10 of San Francisco, et al., San Francisco Superior Court, Court No. 436930 by the payment of a
11 total of \$1,748,840.74, representing the claim for interest on diminution of property values,
12 interest on property damage, and attorney's fees, in the amount per plaintiff as set forth on
13 Attachment A.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 January 31, 2005, and the following parties were named in the lawsuit: All plaintiffs listed on
16 Attachment A; and defendant City and County of San Francisco.


