3 **Ordinance authorizing the Department of Emergency Management to accept and**
4 **expend a federal pass through grant in the amount of \$1,667,904 from the United States**
5 **Department of Homeland Security through the Governor's Office of Homeland Security**
6 **under three grant programs: the State Homeland Security Program (SHSP), the Law**
7 **Enforcement Terrorism Prevention Program (LETPP), and the Metropolitan Medical**
8 **Response System (MMRS), and incorporating an amendment to the Annual Salary**
9 **Ordinance to provide for the extension of certain grant-funded positions.**

14 Be it ordained by the People of the City and County of San Francisco:

15 Section 1. **Findings.**

16 (a) On October 18, 2005, the President signed the Department of Homeland Security
17 Appropriations Act of 2006 which provided approximately \$2.5 billion dollars in funding
18 needed to ensure the safety and security of our nation.

19 (b) The 2006 Homeland Security Grant Program continues to provide funding for
20 planning, organization, equipment, training, exercises, and management and administration to
21 prevent, protect against, respond to, and recover from terrorist attacks major disasters, and
22 other emergencies.

23 (c) In recognition of the fact that funds must be expended wisely, subgrantees now
24 must utilize a risk and need-based allocation process as well as support the National
25 Preparedness Goal and National Priorities.

(d) For the purpose of distributing of state homeland security funds, the United States

1 Department of Homeland Security, the grant was divided into three programs: State
2 Homeland Security Program (SHSP), Law Enforcement Terrorism Prevention Program, and
3 Metropolitan Medical Response System.

4 (e) The City and County of San Francisco has participated in the federal homeland
5 security programs since their inception and deems participation in these programs as vital to
6 the continued well being of its citizens.

7 **Section 2. Authorization to Accept and Expend Grant Funds.**

8 The Department of Emergency Management is hereby authorized to accept and
9 expend on behalf of the City and County of San Francisco \$1,667,904 in funds from the
10 United States Department of Homeland Security through the Governor's Office of Homeland
11 Security under the State Homeland Security Program. The Department of Emergency
12 Management is further authorized to furnish whatever additional information or assurances
13 the funding agencies may request in connection with this grant, and to execute any and all
14 agreements necessary to complete transfer of the funds. The grant does not include and any
15 provisions for indirect costs, indirect costs are hereby waived.

16 **Section 3. Grant-Funded Positions; Amendments to Annual Salary Ordinance.**

17 The positions that will be funded from the fiscal year 2006 grant funds received by the
18 City under the State Homeland Security Grant Program are set forth in Ordinance No 061585,
19 which amends Ordinance No. 203-06 (Annual Salary Ordinance 2006/2007), to extend the
20 duration of four existing positions at the following departments: Department of Emergency
21 Management, Emergency Services Division (DEM), Department of Public Health (DPH), and
22 Sheriff (SHF). The fiscal year 2006 grant funds received by the City under the State
23 Homeland Security Grant Program will fund the following job classifications and FTEs as
24 extended under the amendment to the Annual Salary Ordinance from January 1 through
25 March 30: DPH, 2533 EMS Agency Specialist (0.25 FTE); SHF, 8304 Deputy Sheriff (0.25

1 FTE). The fiscal year 2006 grant funds received by the City under the State Homeland
2 Security Grant Program will fund the following job classifications and FTEs as extended under
3 the amendment to the Annual Salary Ordinance from April 1 through June 30: DEM, 0922
4 Manager I (0.25 FTE); DPH, 2533 EMS Agency Specialist (0.25 FTE); DPH, 2409 Pharmacy
5 Technician (0.25 FTE); SHF, 8304 Deputy Sheriff (0.25 FTE). Ordinance No. 061585, which
6 amends the Annual Salary Ordinance, specifies the number of positions, classification and
7 compensation of positions to be funded by the fiscal year 2006 State Homeland Security
8 Program grant funds and is fully incorporated as set forth herein.




