The Docomomo US/Northern California Board does not see any reason to disagree with the qualified consultant's finding in the Historic Resource Evaluation or with the professional opinion of the City Planning Department in this case. The architect, Conrad T. Kett, has not been identified as a master architect, and the building is a modest expression of Streamline Moderne design which does not appear to be historically significant for its architectural design.
