10 WHEREAS, David M. Bass and Mi Hui Bass are seeking transfer of a Type 48  
11 on-sale general public premises license for Sugar Lounge located at 377 Hayes Street  
12 from 1449 Lombard Street; and,

13 WHEREAS, The City Planning Department has verified that the area is properly  
14 zoned; and,

15 WHEREAS, The Police Department recommends that the liquor license  
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business  
18 and Professions Code, the Board of Supervisors of the City and County of San  
19 Francisco hereby determines for the foregoing reasons that the transfer of a Type 48  
20 on-sale general public premises license from 1449 Lombard Street to 377 Hayes Street  
21 for David M. Bass and Mi Hui Bass for Sugar Lounge, will serve the public convenience  
22 and necessity of the people of the City and County of San Francisco.

23 Conditions: (1) No noise shall be audible beyond the area under control of the  
24 licensee; (2) Petitioners shall not permit their patrons or the general public to loiter or  
25 congregate on the sidewalks adjacent to the licensed premises; (3) The petitioner(s)

1 shall be responsible for maintaining free of litter the area adjacent to the premises over  
2 which they have control; (4) Sales and service of alcoholic beverages shall be permitted  
3 only between the hours of 9:00 a.m. and 11:30 p.m. Sunday through Wednesday,  
4 9:00 a.m. and 1:00 a.m. Thursday, 9:00 a.m. and 2:00 a.m. Friday through Saturday; (5)  
5 No off-sale privileges.




