8 EMPLOYMENT OPPORTUNITY COMMISSION, WITHIN THEIR RESPECTIVE
9 JURISDICTIONS, TO VIGOROUSLY INVESTIGATE ALL ALLEGATIONS OF
10 DISCRIMINATION IN PUBLIC OR PRIVATE WORKPLACES, AND RESPECTFULLY
11 REQUESTS THE CLERK OF THE BOARD TO TRANSMIT A COPY OF THIS RESOLUTION
12 TO CONGRESSWOMAN PELOSI, CONGRESSMAN LANTOS, SENATOR BOXER, SENATOR
13 FEINSTEIN, GOVERNOR DAVIS, STATE SENATOR BURTON, STATE SENATOR
14 SPEIER, ASSEMBLYWOMAN MIGDEN, ASSEMBLYMAN SHELLEY, THE ASSOCIATION OF
15 BAY AREA GOVERNMENTS, AND THE CITY AND COUNTY OF SAN FRANCISCO'S
16 LOBBYISTS IN THE DISTRICT OF COLUMBIA AND SACRAMENTO.

17 WHEREAS, All Americans are entitled to the equal protection of
18 law; and,

19 WHEREAS, Due to recent allegations of espionage and illegal
20 campaign financing, the loyalty and probity of Americans of Asian
21 ancestry has been questioned; and,

22 WHEREAS, Americans of Asian ancestry have made profound
23 contributions to American life, including the arts, our economy,
24 education, the sciences, technology, politics, and sports, among
25 others; and,

1 WHEREAS, Americans of Asian ancestry have demonstrated their
2 patriotism by honorably serving to defend the United States in times
3 of armed conflict, from the Civil War to the present; and,

4 WHEREAS, Americans of Asian ancestry comprise more than 30
5 percent of the population of the City of San Francisco; and,

6 WHEREAS, The City and County of San Francisco recently
7 recognized the contributions of Asian Americans by hosting the first
8 official Asian Pacific Heritage Month at City Hall; and,

9 WHEREAS, H.CON.RES.124 was submitted to Congress by Congressman
10 David Wu and Congressman Tom Campbell on May 27, 1999; now,
11 therefore, be it

12 RESOLVED, That the Board of Supervisors of the City and County
13 of San Francisco supports H.CON.RES.124 sponsored by Congressman
14 David Wu and Congressman David Campbell expressing the sense of the
15 Congress relating to recent allegations of espionage and illegal
16 campaign financing that have brought into question the loyalty and
17 probity of Americans of Asian ancestry; and be it

18 FURTHER RESOLVED, That the Board of Supervisors of the City and
19 County of San Francisco urges the United States Attorney General, the
20 United States Secretary of Energy, and the United States Commissioner
21 of the Equal Employment Opportunity Commission, within their
22 respective jurisdictions, to vigorously investigate all allegations
23 of discrimination in public or private workplaces; and be it




