
9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. The San Francisco Administrative Code is hereby amended by adding  
11 Section 7.19, to read as follows:

12 **SEC. 7.19. BOARD OF SUPERVISORS' REVIEW OF CITY'S STATE OF DISASTER**  
13 **PREPAREDNESS.**

14 At least once a year, the Board of Supervisors if requested by the Mayor, the Board of  
15 Supervisors, sitting as a committee of the whole, or a committee of the Board, shall hold a hearing on  
16 the state of the City's disaster preparedness. The Board may call upon any City officer, employee, or  
17 department to provide information necessary or appropriate for the hearing.


