11 WHEREAS, Pacific Retail VFC 1, Inc., dba Vom Fass Oils Vinegar Spirits is
12 seeking the issuance of a Type 42 on-sale beer and wine license located at 900 North
13 Point Street E205 (District 2); and

14 WHEREAS, The Planning Department has verified that the area is properly
15 zoned and recommends approval; and

16 WHEREAS, The Police Department has filed zero (0) protests and zero (0)
17 letters of support with the Department of Alcoholic Beverage Control under California
18 Business and Professions Code, Section 24013, and recommends that the Department
19 of Alcoholic Beverage Control issue the liquor license with conditions; and

20 WHEREAS, The conditions recommended by the Police Department are the
21 following: 1) Sales, service and consumption of alcoholic beverages shall be permitted
22 between the hours of 10:00 a.m. and 11:00 p.m. daily; 2) signs shall be posted at a
23 conspicuous space at the entrances and/or exits of the premises as depicted on the
24 ABC-257 dated 12/18/2015 which will state: NO ALCOHOLIC BEVERAGES BEYOND
25 THIS POINT." Said signs shall be no less than 7"x11" in size and contain lettering no

1 less than 1" in height; and 3) the licensee(s) or an employee of the licensee(s) will be
2 present in the patio at all times that alcoholic beverages are being served or consumed;
3 now, therefore, be it

4 RESOLVED, That in accordance with California Business and Professions Code,
5 Section 23958.4, the Board of Supervisors of the City and County of San Francisco
6 hereby determines that the issuance of a Type 42 on-sale beer and wine license to
7 Pacific Retail VFC 1, Inc., dba Vom Fass Oils Vinegar Spirits, located at 900 North Point
8 Street E205 (District 2), will serve the public convenience or necessity of the City and
9 County of San Francisco; and, be it

10 FURTHER RESOLVED, That the Board of Supervisors of the City and County of
11 San Francisco hereby endorses and adopts the recommendations of the Police
12 Department listed above and recommends that the Department of Alcoholic Beverage
13 Control issue the license with those conditions.


