6 **April 22, 2016, in San Francisco Superior Court, Case No. CGC-16-551618; entitled Jane**
7 **Doe v. The City and County of San Francisco, et al.; the lawsuit involves an alleged**
8 **unauthorized disclosure of medical information.**

10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
12 authorizes the City Attorney to settle the action entitled Jane Doe v. The City and County of
13 San Francisco, et al., San Francisco Superior Court, Case No. CGC-16-551618 by the
14 payment of \$100,000 by The Regents of The University of California to the City and County of
15 San Francisco. The lawsuit involves an alleged unauthorized disclosure of medical
16 information.

17 Section 2. The above-named action was filed in San Francisco Superior Court on
18 April 22, 2016, and the following parties were named in the lawsuit: Plaintiff: Jane Doe;
19 Defendants: City and County of San Francisco, Zuckerberg San Francisco General Hospital
