[Settlement of Lawsuit - United Airlines, Inc. - City to Receive \$165,000]

Ordinance authorizing settlement of the lawsuit filed by the City and County of San Francisco against United Airlines, Inc. for \$165,000; the lawsuit was filed on August 2, 2016, in San Mateo County Superior Court, Case No. 16ClV00748, entitled City and County of San Francisco v. United Airlines, Inc., and removed to the United States District Court for the Northern District of California on September 13, 2016, Case No. 3:16-cv-05234-MEJ; the lawsuit involves claims against United Airlines, Inc. for negligence and breach of contract for causing damage to City-owned computer equipment; other material terms of the settlement are each side to bear its own fees and costs, the City will dismiss its complaint with prejudice, and the parties will enter into mutual releases.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>City and County of San Francisco v.</u>

<u>United Airlines, Inc.</u>, United States District Court, Northern District of California, Case No. 3:16-cv-05234-MEJ, by the payment of \$165,000 by United Airlines, Inc. and each side to bear its own fees and costs, the City to dismiss its complaint with prejudice, and the parties to enter into mutual releases. The lawsuit involves claims against United for negligence and breach of contract for causing damaged to City-owned computer equipment.

Section 2. The above-named action was filed in San Mateo County Superior Court on August 2, 2016 and then removed to the United States District Court for the Northern District of California on September 13, 2016, and the following parties were named in the lawsuit: City and County of San Francisco, plaintiff, and United Airlines, Inc., defendant.
