Describe the nature of the contract that was approved: The contractor will provide project management support services to assist the Airport for the Airport's Terminal 1 Center Renovation Project ("Project") in a coordinated and methodical manner. Specific areas of expertise required include: Airport boarding area design management and construction phasing, project-level cost/schedule controls, solicitations and contract preparation, alternative project delivery processes, project management/construction management coordination, cost estimating, industry outreach/workshops, document control, program management systems, and other administrative support functions and operations. The Project will include the central area of the main Terminal 1 building, including construction of a new consolidated passenger screening checkpoint, pre-security ticket counters and concessions, as well as post-security passenger amenities consistent with Terminal 2 and Terminal 3 Boarding Area E and to meet the increasing passenger forecast envisioned.


