Be it ordained by the People of the City and County of San Francisco:

Section 1. Findings.

The Planning Department has determined that the actions contemplated in this Ordinance are in compliance with the California Environmental Quality Act (California Public Resources Code sections 21000 et. seq.). Said determination is on file with the Clerk of the Board of Supervisors in File No. 090719 and is incorporated herein by reference.

Section 2. The San Francisco Park Code is hereby amended by amending Section 12.30, to read as follows:

SEC. 12.30. LATCH KEY AND AFTERSCHOOL PROGRAMS.

The following fees shall be charged for ~~the~~ Latch Key ~~and Afterschool P~~programs, ~~which provides recreational and tutorial programs, and a nutritious snack, after school and during the summer at certain neighborhood recreation centers:~~

School year (Monday--Friday)	\$30.00/month \$3.60 per day
Summer (Monday--Friday)	\$80.00/month


