6 **Angelo Dumlao v. City of San Francisco, et al.; the lawsuit involves alleged personal**
7 **injury from a two vehicle rear-end collision.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Angelo Dumlao v. City of San
12 Francisco, et al., San Francisco Superior Court, CGC-20-582729 Case No. by the payment
13 of \$100,000. The lawsuit involves alleged personal injury from a two vehicle rear-end
14 collision.

15 Section 2. The above-named action was filed in San Francisco Superior Court on
16 February 5, 2020, and the following parties were named in the lawsuit: Plaintiff Angelo
17 Dumlao; Defendants City of San Francisco, County of San Francisco, San Francisco
