AMENDING ORDINANCE NO. 103-98 TO REDEFINE UNDERGROUND DISTRICT NO. 331 IN THE TEXAS AND 19TH STREET AREA BY ADDING CERTAIN PROPERTY THERETO.

NOTE: Additions are indicated by <u>underlining</u>; deletions are in ((double parentheses)).

Be it ordained by the people of the City and County of San Francisco:

Section 1. In accordance with the provisions of Section 901, et seq. of Article 18, Chapter X, Part II of the San Francisco Municipal Code (Public Works Code), the Board of Supervisors does hereby create the following underground district:

Underground District No. 331

(Texas and 19th Street)

District covering Texas Street from the southerly line of 18th Street to the northerly line of 20th Street, Mississippi Street from the southerly line of 18th Street to the northerly line of 20th Street, 19th Street from the easterly line of ((Missouri)) Connecticut Street to the westerly line of Pennsylvania Street, 20th Street from the easterly line of Missouri Street to the westerly line of Pennsylvania Street, Missouri Street from the southerly line of 18th Street to the northerly line of 19th Street, and Connecticut Street from the southerly line of 18th to the northerly line of 19th Street.

Section 2. The undergrounding of facilities within this underground district is in the general public interest in that said action will eliminate a heavy concentration of overhead wires.

Section 3. All work in connection with the undergrounding of facilities lying within this underground district and subject to the laws with reference to underground districts is to be completed in accordance with the Department of Public Works' program; provided, however, that said work shall be commenced at such time or according to such priority as the Department of Public Works has established.

Section 4. The Board hereby requests that the utility companies providing the undergrounding of facilities within this underground district pay for up to 100 feet of each underground service lateral occasioned by the undergrounding.
