7 Moved, That the Board of Supervisors of the City and County of San Francisco does
8 hereby appoint the hereinafter designated persons to serve as members of the Voting System
9 Task Force, pursuant to the provisions of the San Francisco Administrative Code Sections
10 5.400-410, for the terms specified:

11 Joanne Sanford, new assignment, seat 1, must represent good government groups, for
12 two-year term to be determined.

13 ~~Brent Turner, new assignment, seat 2, must represent good government groups, for~~
14 ~~two-year term to be determined.~~

15 Ka-Ping Yee, new assignment, seat 3, must have substantial background in computer
16 science or the software or computer industry, for two-year term to be determined.

17 Gregory Miller, new assignment, seat 4, must have substantial background in computer
18 science or the software or computer industry, for two-year term to be determined.

19 Beth Mazur, new assignment, seat 5, must have substantial background in computer
20 science or the software or computer industry, for two-year term to be determined.

21 Tim Mayor, new assignment, seat 6, must have substantial background in computer
22 science or the software or computer industry, for two-year term to be determined.

23 Elizabeth Bergman, new assignment, seat 7, must have a background in or knowledge
24 of election administration, for two-year term to be determined.

1 Roger Donaldson, new assignment, seat 8, must have a background in or knowledge
2 of election administration, for two-year term to be determined.

3 FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 4 1. The membership of the Voting Systems Task Force has a goal to be representative
5 of the diversity of the City and County of San Francisco.
- 6 2. Applicants ~~Brent Turner~~, Elizabeth Bergman, Gregory Miller and Ka-Ping Yee new
7 appointees, who are not a resident of San Francisco, are persons with experience
8 that uniquely qualifies them to serve on the Voting Systems Task Force.
- 9 3. The Voting Systems Task Force has attempted to fill these positions, for which
10 ~~Brent Turner~~, Elizabeth Bergman, Gregory Miller and Ka-Ping Yee were nominated,
11 with individuals who are City residents and who have the specific experience, skills,
12 and qualifications, but has been unable to do so at this time. The Rules Committee
13 has certified that ~~Brent Turner~~, Elizabeth Bergman, Gregory Miller and Ka-Ping Yee
14 are qualified to serve on the Voting Systems Task Force.
- 15 4. After exercising due diligence, the Board of Supervisors concludes that there are no
16 other possible representatives, who are residents of San Francisco and who have
17 the specific experience, skills, or qualifications possessed by these applicants, and
18 who are willing to serve on the Voting Systems Task Force at this time; and, be it

19 FURTHER MOVED, That the Board of Supervisors waives the residency requirement
20 for ~~Brent Turner~~, Elizabeth Bergman, Gregory Miller and Ka-Ping Yee, as allowed in cases
21 where no qualified City residents, willing to serve, can be found, pursuant to Section 4.101 of
22 the City Charter that requires person(s) appointed to boards, commissions, and advisory
23 bodies established by legislative act of the Board of Supervisors to be resident(s) of the City
24 and County of San Francisco.
