WHEREAS, SFDPH, AIDS has been awarded a grant from DHHS, HRSA in the amount of \$75,000 for transgender cultural competency training; and,

WHEREAS, As a condition of receiving the grant funds, DHHS, HRSA requires the City to enter into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the Board of Supervisors in File No. 040076 , which is hereby declared to be a part of this resolution as if set forth fully herein; and,

WHEREAS, This Resolution requires expedited review by the Board of Supervisors because we did not receive the grant award notice until August 18, 2003; and,

WHEREAS, Resolutions authorizing the acceptance and expenditure of grant funds may be placed automatically on the consent agendas in committee, as they are usually considered to be routine items, and this resolution authorizes the acceptance and expenditure of grant funding; and,

WHEREAS, The grant terms prohibit including indirect costs in the grant budget; now, therefore, be it

RESOLVED, That SFDPH, AIDS is hereby authorized to accept retroactively and expend a grant in the amount of \$75,000 from DHHS, HRSA; and, be it
