10 **collaboration with the Family Resource Centers, and staffing for the Office of Early**
11 **Care and Education to support the work of implementing the 5-year spending plan (File**
12 **No. 201361); and scheduling the Board of Supervisors to sit as a Committee of the**
13 **Whole on December 22, 2020, to hold the Hearing.**

15 WHEREAS, On December 9, 2020, the Office of Early Care and Education submitted a
16 memo requesting the release of reserved funds to the Office of Early Care and Education for
17 All, placed on the Budget and Finance Committee reserve by Ordinance No. 165-20 in the
18 amount of \$42,000,000 to fund the Early Education Economic Recovery Grant and Loan
19 program, subsidy outlays to provide additional access to child care, supplementing the
20 CARES 2.0 teacher stipend, community response in collaboration with the Family Resource
21 Centers, and staffing for the Office of Early Care and Education to support the work of
22 implementing the 5-year spending plan; and

23 WHEREAS, The Hearing (File No. 201361) to consider the request for release of funds
24 was held at a Special Budget and Finance Committee meeting on December 16, 2020, but
25 was continued to the Call of the Chair where action is currently pending; now, therefore, be it

1 MOVED, That under Rule 3.37 of the San Francisco Board of Supervisors' Rules of
2 Order, the Board hereby orders the Hearing to consider the release of \$42,000,000 in
3 reserved funds to the Office of Early Care and Education for All, be called from the Budget
4 and Finance Committee to the full Board of Supervisors; and, be it

5 FURTHER MOVED, That the Board of Supervisors shall convene to sit as a Committee
6 of the Whole on December 22, 2020, to hold the public Hearing (File No. 201361) to consider
7 the release of funds requested.


