3 **Ordinance authorizing settlement of the lawsuit filed by Ying Zhang and Chen Li**
4 **against the City and County of San Francisco for \$175,000; the lawsuit was filed on**
5 **January 21, 2014, in San Francisco Superior Court, Case No. CGC-14-536903**
6 **(consolidated with CGC-13-536533); entitled Ying Zhang, et al. v. City and County of**
7 **San Francisco, et al.; the lawsuit involves an alleged dangerous condition of public**
8 **property causing personal injury; other materials terms of said settlement are that the**
9 **Municipal Transportation Agency is to also pay \$175,000, subject to approval by the**
10 **Municipal Transportation Agency Board.**

12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby
14 authorizes the City Attorney to settle the action entitled Ying Zhang, et al. v. City and County
15 of San Francisco, San Francisco Superior Court, Case No. CGC-14-536903 (consolidated
16 with CGC-13-536533) by the payment of \$175,000; other materials terms of said settlement
17 are that the Municipal Transportation Agency is to also pay \$175,000, subject to approval by
18 the Municipal Transportation Agency Board. The lawsuit involves an alleged dangerous
19 condition of public property causing personal injury

20 Section 2. The above-named action was filed in San Francisco Superior Court on
21 January 21, 2014, and the following parties were named in the lawsuit: Plaintiffs: Ying Zhang
22 and Chen Li, Defendants: City and County of San Francisco and Gina Eunice.




