11 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby

13 of San Francisco, et al.), United States District Court, Case No. 18-cv-06097 by the payment
14 of \$225,000. The lawsuit involves alleged civil rights violations.


