RESOLUTION NO. 381-00

1 [Neighborhood Park General Obligation Bond Sale]

2 AUTHORIZING AND DIRECTING THE SALE OF NOT TO EXCEED \$6,180,000 CITY AND
3 COUNTY OF SAN FRANCISCO GENERAL OBLIGATION BONDS (NEIGHBORHOOD
4 RECREATION AND PARK FACILITIES IMPROVEMENT BONDS, 2000), SERIES 2000C;
5 PRESCRIBING THE FORM AND TERMS OF SAID BONDS; AUTHORIZING THE
6 EXECUTION, AUTHENTICATION AND REGISTRATION OF SAID BONDS; PROVIDING FOR
7 THE APPOINTMENT OF DEPOSITORIES AND OTHER AGENTS FOR SAID BONDS;
8 PROVIDING FOR THE ESTABLISHMENT OF ACCOUNTS RELATED THERETO;
9 APPROVING THE FORMS OF OFFICIAL NOTICE OF SALE AND NOTICE OF INTENTION
10 TO SELL BONDS; DIRECTING THE PUBLICATION OF THE NOTICE OF INTENTION TO
11 SELL BONDS; APPROVING THE FORM AND EXECUTION OF THE OFFICIAL STATEMENT
12 RELATING THERETO; APPROVING THE FORM OF THE CONTINUING DISCLOSURE
13 CERTIFICATE; APPROVING MODIFICATIONS TO DOCUMENTS; RATIFYING CERTAIN
14 ACTIONS PREVIOUSLY TAKEN; AND GRANTING GENERAL AUTHORITY TO CITY
15 OFFICIALS TO TAKE NECESSARY ACTIONS IN CONNECTION WITH THE
16 AUTHORIZATION, ISSUANCE, SALE AND DELIVERY OF SAID BONDS.

17 WHEREAS, By Resolution No 381-00, (the "Authorizing Resolution") adopted by the
18 Board of Supervisors (the "Board of Supervisors") of the City and County of San Francisco (the
19 "City") on May 1, 2000, the City authorized the issuance of its Neighborhood Recreation
20 and Park Facilities Improvement Bonds, 2000; and,

21 WHEREAS, It is necessary and desirable to issue a portion of said Bonds in a single
22 series as City and County of San Francisco General Obligation Bonds (Neighborhood
23 Recreation and Park Facilities Improvement, 2000), Series 2000C (the "Bonds"); and,

24 WHEREAS, The Bonds are being issued pursuant to the Authorizing Resolution and
25 Title 5, Division 2, Part 1, Chapter 3, Article 4.5 of the California Government Code (the "Act"),

1 the Charter of the City and a duly held election; and,

2 WHEREAS, The City and County of San Francisco (the "City") expects to pay certain
3 expenditures in connection with the projects to be financed by the Bonds prior to the issuance
4 and sale of the Bonds, and the City intends to reimburse itself and to pay third parties for such
5 prior expenditures from the proceeds of the Bonds; and,

6 WHEREAS, Section 1.150-2 of the Treasury Regulations promulgated under the Internal
7 Revenue Code of 1986 (the "Treasury Regulations") requires the City to declare its reasonable
8 official intent to reimburse prior expenditures with the proceeds of a subsequent borrowing; and,

9 WHEREAS, The Treasury Regulations require that any reimbursement allocation of
10 proceeds of the Bonds to be made with respect to expenditures incurred prior to the issuance of
11 the Bonds will occur not later than eighteen (18) months after the later of (i) the date on which
12 the expenditure is paid or (ii) the date on which the facilities are placed in service, but in no
13 event later than three (3) years after the expenditure is paid; and,

14 WHEREAS, The adoption of this Resolution shall constitute authorization of the Bonds
15 within the meaning of Section 864 of the California Code of Civil Procedure;

16 NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the City and
17 County of San Francisco, as follows:

18 Section 1. Recitals. All of the recitals herein are true and correct.

19 Section 2. Conditions Precedent. All conditions, things and acts required by law to exist,
20 to happen and to be performed precedent to and in the issuance of the Bonds exist, have
21 happened and have been performed in due time, form and manner in accordance with
22 applicable law, and the City is now authorized pursuant to its Charter and applicable law to
23 incur indebtedness in the manner and form provided in this Resolution.

24 Section 3. Documents. The documents presented to this Board of Supervisors and on
25 file with the Clerk of the Board of Supervisors are contained in File No. 000679.

1 Section 4. Issuance and Sale of Bonds. The Board of Supervisors hereby authorizes
2 the issuance and sale of not to exceed \$6,180,000 aggregate principal amount of bonds to be
3 designated as "City and County of San Francisco General Obligation Bonds (Neighborhood
4 Recreation and Park Facilities Improvement Bonds, 2000), Series 2000C" for the purposes set
5 forth in the Authorizing Resolution. The Director of Public Finance of the City (the "Director of
6 Public Finance") is hereby authorized to determine the sale date, the maturity dates and the
7 redemption dates of the Bonds, subject to the following terms and conditions: (i) the Bonds shall
8 not have a true interest cost in excess of 12% (as such term is defined in the Official Notice of
9 Sale); (ii) the Bonds shall not have a final maturity date after June 15, 2026; and (iii) any original
10 issue discount on the purchase of the Bonds shall not exceed 2% of the principal amount of the
11 Bonds. The Director of Public Finance is further authorized to give the Bonds such additional or
12 other series designation as may be necessary or appropriate to distinguish such series from
13 every other series and from other bonds issued by the City.

14 Section 5. Execution, Authentication and Registration of the Bonds. The Bonds shall be
15 in fully registered form without coupons in denominations of \$5,000 or any integral multiple
16 thereof. The officers of the City are hereby directed to cause the Bonds to be prepared in
17 sufficient quantity for delivery to the purchaser thereof and the Clerk of the Board of Supervisors
18 is hereby directed to cause the blanks therein to be completed in accordance with the
19 Authorizing Resolution, to cause the seal of the City to be reproduced or impressed thereon, to
20 procure their execution by the proper officers of the City, and to deliver the Bonds when so
21 executed to said purchaser in exchange for the purchase price thereof.

22 The Bonds and the certificate of authentication and registration of the Treasurer of the
23 City (the "City Treasurer") and the form of assignment to appear thereon shall be substantially in
24 the form attached hereto as Exhibit A (a copy of which is on file with the Clerk of the Board of
25 Supervisors and which is hereby declared to be a part of this Resolution as if fully set forth

1 herein) with necessary or appropriate variations, omissions and insertions as permitted or
2 required by this Resolution.

3 Only such of the Bonds as shall bear thereon a certificate of authentication and
4 registration in the form herein recited, executed by the City Treasurer, shall be valid or
5 obligatory for any purpose or entitled to the benefits of this Resolution, and such certificate of
6 the City Treasurer shall be conclusive evidence that the Bonds so authenticated have been duly
7 authenticated and delivered hereunder and are entitled to the benefits of this Resolution.

8 The City Treasurer shall assign a distinctive letter, or number, or letter and number to
9 each Bond authenticated and registered by him or her and shall maintain a record thereof which
10 shall be available for inspection.

11 Section 6. Registration Books. The City Treasurer shall keep or cause to be kept, at the
12 office of the City Treasurer, sufficient books for the registration and transfer of the Bonds, which
13 shall at all times be open to inspection, and upon presentation for such purpose, the City
14 Treasurer shall, under such reasonable regulations as he or she may prescribe, register or
15 transfer or cause to be registered or transferred, on said books, Bonds as herein provided.

16 Section 7. Transfer or Exchange of Bonds. Any Bond may, in accordance with its terms,
17 be transferred upon the books required to be kept pursuant to the provisions of Section 6
18 hereof, by the person in whose name it is registered, in person or by the duly authorized
19 attorney of such person in writing, upon surrender of such Bond for cancellation, accompanied
20 by delivery of a duly executed written instrument of transfer in a form approved by the City
21 Treasurer.

22 Any Bonds may be exchanged at the office of the City Treasurer for a like aggregate
23 principal amount of other authorized denominations of the same interest rate and maturity.

24 Whenever any Bond shall be surrendered for transfer or exchange, the designated City
25 officials shall execute (as provided in Section 5 hereof) and the City Treasurer shall authenticate

1 and deliver a new Bond or Bonds of the same interest rate and maturity in a like aggregate
2 principal amount. The City Treasurer shall require the payment by any bond owner requesting
3 any such transfer of any tax or other governmental charge required to be paid with respect to
4 such transfer or exchange.

5 No transfer or exchange of Bonds shall be required to be made by the City Treasurer
6 during the period from the Record Date (as defined herein) next preceding each interest
7 payment date to such interest payment date or after a notice of redemption shall have been
8 mailed with respect to such Bond.

9 Section 8. Terms of the Bonds; General Redemption Provisions. The Bonds shall each
10 be dated the first day of the month in which the Bonds are sold or such other date (the "Dated
11 Date") as specified in the award to be made by motion of the Finance Committee of the Board
12 of Supervisors pursuant to Section 13 hereof (the "Finance Committee Award"). The Bonds
13 shall bear interest from the date thereof until paid (at rates to be determined upon sale of the
14 Bonds) calculated on the basis of a 360-day year comprised of twelve 30-day months, payable
15 on December 15, 2000, and semiannually thereafter on June 15 and December 15 of each year
16 (or such other dates as may be designated in the Finance Committee Award).

17 The principal of the Bonds shall be payable in lawful money of the United States of
18 America to the owner thereof, upon the surrender thereof at maturity or earlier redemption at
19 the office of the City Treasurer. The interest on the Bonds shall be payable in like lawful money
20 to the person whose name appears on the bond registration books of the City Treasurer as the
21 owner thereof as of the close of business on the last day of the month immediately preceding
22 an interest payment date (the "Record Date"), whether or not such day is a Business Day (as
23 herein defined).

24 Each Bond shall bear interest from the interest payment date next preceding the date of
25 authentication thereof unless it is authenticated as of a day during the period from the Record

1 Date next preceding any interest payment date to the interest payment date, inclusive, in which
2 event it shall bear interest from such interest payment date, or unless it is authenticated on or
3 before November 30, 2000 (or such other date as may be designated in the Finance Committee
4 Award), in which event it shall bear interest from the Dated Date; provided, however, that if, at
5 the time of authentication of any Bond, interest is in default on the Bonds, such Bond shall bear
6 interest from the interest payment date to which interest has previously been paid or made
7 available for payment on the Bonds or from the Dated Date if the first interest payment is not
8 made. Payment of the interest on any Bond shall be paid by check mailed to such owner at
9 such owner's address as it appears on the registration books as of the Record Date; provided,
10 however, if any interest payment occurs on a day that banks in California and New York are
11 closed for business, then such payment shall be made on the next succeeding day that banks
12 in both California and New York are open for business and the New York Stock Exchange is
13 open for business (a "Business Day"); and provided, further, that the registered owner of an
14 aggregate principal amount of at least \$1,000,000 of the Bonds may submit a written request to
15 the City Treasurer on or before a Record Date preceding an interest payment date for payment
16 of interest by wire transfer to a commercial bank located within the continental United States.
17 For so long as Cede & Co. or its registered assignee is the registered owner of all of the Bonds,
18 payment shall be made by wire transfer of immediately available funds to Cede & Co.

19 The Bonds maturing on or before June 15, 2008 (or such other date as may be
20 designated in the Finance Committee Award) shall not be subject to optional redemption prior to
21 maturity. The Bonds maturing on or after June 15, 2009 (or such other date as may be
22 designated in the Finance Committee Award) are subject to optional redemption prior to their
23 respective stated maturities, at the option of the City, from any source of available funds, as a
24 whole or in part on any date (with the maturities to be redeemed to be determined by the City
25 and by lot within a maturity) on or after June 15, 2008 (or such other date as may be designated

1 in the Finance Committee Award), at redemption prices equal to 102% of the principal amount
2 redeemed in the first year the Bonds are subject to optional redemption (with such redemption
3 price declining to 100% at the rate of 1% annually), together with accrued interest to the date of
4 redemption, or such other redemption prices as may be designated in the Finance Committee
5 Award.

6 The Bonds shall be subject to mandatory redemption at par, by lot, in any year for which
7 the successful bidder therefor has designated that the principal amount payable with respect to
8 that year shall constitute a mandatory sinking fund payment as permitted by the Official Notice
9 of Sale (as more fully described in Section 13 hereof). Any Bonds subject to mandatory
10 redemption shall be designated as such in the Finance Committee Award. The principal and
11 interest on Series 2000C Bonds subject to mandatory redemption shall be paid from the Series
12 2000C Bond Account pursuant to Section 9 hereof. In lieu of any such mandatory redemption,
13 at any time prior to the selection of the Bonds for redemption, the City may apply such amounts
14 on deposit in the Series 2000C Bond Account (as defined in Section 9 hereof) to make such
15 payment to the purchase of Bonds subject to such redemption at public or private sale, as and
16 when and at such prices not in excess of the principal amount thereof (including brokerage and
17 other charges but excluding accrued interest), as the City may determine.

18 The date on which the Bonds which are called for redemption are to be presented for
19 redemption is herein sometimes called the "redemption date." Notice of any redemption of
20 Bonds shall be mailed, postage prepaid, to the respective registered owners thereof at the
21 addresses appearing on the bond registration books not less than thirty (30) nor more than sixty
22 (60) days prior to the redemption date. The notice of redemption shall (a) state the redemption
23 date; (b) state the redemption price; (c) state the dates of maturity of the Bonds and, if less than
24 all of any such maturity is called for redemption, the distinctive numbers of the Bonds of such
25 maturity to be redeemed, and in the case of Bonds redeemed in part only, the respective

1 portions of the principal amount thereof to be redeemed; (d) state the CUSIP number, if any, of
2 each Bond to be redeemed; (e) require that such Bonds be surrendered by the owners at the
3 office of the City Treasurer or his or her agent; and (f) give notice that interest on such Bonds
4 will cease to accrue after the designated redemption date.

5 The actual receipt by the owner of any Bond of notice of such redemption shall not be a
6 condition precedent to redemption, and failure to receive such notice, or any defect in such
7 notice, shall not affect the validity of the proceedings for the redemption of such Bonds or the
8 cessation of accrual of interest on the redemption date.

9 At least five (5) days before the above notice date, notice also shall be given by
10 (i) registered or certified mail, postage prepaid, (ii) confirmed facsimile transmission or
11 (iii) overnight delivery service, to (i) all organizations registered with the Securities and
12 Exchange Commission as securities depositories, (ii) to at least two information services of
13 national recognition which disseminate redemption information with respect to municipal
14 securities, and (iii) as may be further required in accordance with the Continuing Disclosure
15 Certificate described in Section 18 hereof.

16 The notice or notices required for redemption shall be given by the City Treasurer, or any
17 agent appointed by the City. A certificate of the City Treasurer or such other appointed agent of
18 the City that notice of redemption has been given to the owner of any Bond in accordance with
19 this Resolution shall be conclusive against all parties.

20 At the time the City Treasurer or Controller determines to optionally call and redeem any
21 of the Bonds, the City Treasurer or his or her agent shall establish a redemption account to be
22 described or known as the "General Obligation Bonds (Neighborhood Recreation and Park
23 Facilities Improvement Bonds, 2000), Series 2000C Redemption Account" (the "Series 2000C
24 Redemption Account") and prior to or on the redemption date there must be set aside in said
25 Series 2000C Redemption Account moneys available for the purpose and sufficient to redeem

1 as provided in this Resolution, the Bonds designated in said notice of redemption. Said
2 moneys must be set aside in the Series 2000C Redemption Account solely for the purpose of,
3 and shall be applied on or after the redemption date to, payment of the redemption price of the
4 Bonds to be redeemed upon presentation and surrender of such Bonds. Any interest due on or
5 prior to the redemption date may be paid from the Series 2000C Bond Account as provided in
6 Section 9 hereof or from the Series 2000C Redemption Account. Moneys held from time to
7 time in the Series 2000C Redemption Account shall be invested by the City Treasurer pursuant
8 to the City's policies and guidelines for investment of General Fund moneys or pursuant to any
9 resolution authorizing the issuance of refunding bonds or escrow agreement relating thereto. If,
10 after all of the Bonds have been redeemed and canceled or paid and canceled, there are
11 moneys remaining in said Series 2000C Redemption Account, said moneys shall be transferred
12 to the General Fund of the City; provided, however, that if said moneys are part of the proceeds
13 of refunding bonds, said moneys shall be transferred pursuant to the resolution authorizing such
14 refunding bonds.

15 When notice of optional redemption has been given, substantially as provided herein,
16 and when the amount necessary for the redemption of the Bonds called for redemption
17 (principal and premium, if any) is set aside for that purpose in said Series 2000C Redemption
18 Account, as provided herein, the Bonds designated for redemption shall become due and
19 payable on the date fixed for redemption thereof, and upon presentation and surrender of said
20 Bonds at the place specified in the notice of redemption, such Bonds shall be redeemed and
21 paid at said redemption price out of said Series 2000C Redemption Account. No interest will
22 accrue on such Bonds called for redemption after the redemption date and the registered
23 owners of such Bonds shall look for payment of such Bonds only to said Series 2000C
24 Redemption Account. All Bonds redeemed shall be canceled forthwith by the City Treasurer
25 and shall not be reissued.

1 The City may rescind any optional redemption and notice thereof for any reason on any
2 date prior to the date fixed for redemption by causing written notice of the rescission to be given
3 to the owners of all Bonds so called for redemption. Any optional redemption and notice thereof
4 shall be rescinded if for any reason on the date fixed for redemption funds are not available in
5 the Series 2000C Redemption Account in an amount sufficient to pay in full on said date the
6 principal of, interest, and any premium due on the Bonds called for redemption. Notice of
7 rescission of redemption shall be given in the same manner notice of redemption was originally
8 given. The actual receipt by the owner of any Bond of notice of such rescission shall not be a
9 condition precedent to rescission, and failure to receive such notice or any defect in such notice
10 shall not affect the validity of the rescission.

11 Section 9. Series 2000C Bond Account. There is hereby established with the City
12 Treasurer a special subaccount in the General Obligation Bonds (Neighborhood Recreation
13 and Park Facilities Improvement Bonds, 2000) Bond Account (the "Bond Account") created
14 pursuant to the Authorizing Resolution, to be designated the "General Obligation Bonds
15 (Neighborhood Recreation and Park Facilities Improvement Bonds, 2000), Series 2000C
16 Bond Account" (the Series 2000C Bond Account"), to be held separate and apart from all
17 other accounts of the City. All interest earned on amounts on deposit in the Series 2000C
18 Bond Account shall be deposited in the Series 2000C Bond Account.

19 On or prior to the date on which any payment of principal or interest on the Bonds is
20 due, including any Bonds subject to mandatory redemption on said date, the City Treasurer
21 shall allocate to and deposit in the Series 2000C Bond Account, from amounts held in the
22 Bond Account pursuant to Section 9 of the Authorizing Resolution, an amount which, when
23 added to any available moneys contained in the Series 2000C Bond Account, is sufficient to
24 pay principal and interest on the Bonds on such date.

1 On or prior to the date on which any Bonds are to be redeemed at the option of the
2 City pursuant to this Resolution, the City Treasurer may allocate to and deposit in the Series
3 2000C Redemption Account, from amounts held in the Bond Account pursuant to Section 9 of
4 the Authorizing Resolution, an amount which, when added to any available moneys contained
5 in the Series 2000C Bond Account, is sufficient to pay principal and interest and any premium
6 on the Bonds on such date. The City Treasurer may make such other provision for the
7 payment of principal and interest and any redemption premium on the Bonds as is necessary
8 or convenient to permit the optional redemption of the Bonds.

9 Amounts in the Series 2000C Bond Account may be invested in any investment of the
10 City in which moneys in the General Fund of the City are invested. The City Treasurer may
11 commingle any of the moneys held in the Series 2000C Bond Account with other City moneys
12 or deposit amounts credited to the Series 2000C Bond Account into a separate fund or funds
13 for investment purposes only; *provided, however*, that all of the moneys held in the Series
14 2000C Bond Account hereunder shall be accounted for separately notwithstanding any such
15 commingling or separate deposit by the City Treasurer.

16 Section 10. Series 2000C Project Account. There is hereby established with the City
17 Treasurer a special subaccount in the General Obligation Bonds (Neighborhood Recreation
18 and Park Facilities Improvement Bonds, 2000) Project Account (the "Project Account")
19 created pursuant to the Authorizing Resolution, to be designated the "General Obligation
20 Bonds (Neighborhood Recreation and Park Facilities Improvement Bonds, 2000), Series
21 2000C Project Account" (the Series 2000C Project Account"), to be held separate and apart
22 from all other accounts of the City. All interest earned on amounts on deposit in the Series
23 2000C Project Account shall be deposited in the Series 2000C Project Account. Amounts in
24 the Series 2000C Project Account shall be expended for the acquisition, construction and
25 reconstruction of the Project in accordance with the provisions of the Authorizing Resolution.

1 Amounts in the Series 2000C Project Account may be invested in any investment of
2 the City in which moneys in the General Fund of the City are invested. The City Treasurer
3 may commingle any of the moneys held in the Series 2000C Project Account with other City
4 moneys or deposit amounts credited to the Series 2000C Project Account into a separate
5 fund or funds for investment purposes only; *provided, however,* that all of the moneys held in
6 the Series 2000C Project Account hereunder shall be accounted for separately
7 notwithstanding any such commingling or separate deposit by the City Treasurer.

8 The City Treasurer is hereby authorized to pay or cause to be paid from the proceeds
9 of the Bonds, on behalf of the City, the costs of issuance associated with the Bonds. Costs of
10 issuance of the Bonds shall include, without limitation, bond and financial printing expenses,
11 mailing and publication expenses, rating agency fees, the fees and expenses of paying
12 agents, registrars, financial consultants and bond counsel and the reimbursement of
13 departmental expenses in connection with the issuance of the Bonds.

14 Section 11. Appointment of Depositories and Other Agents. The City Treasurer is
15 hereby authorized and directed to appoint one or more depositories as he or she may deem
16 desirable and the provisions of Section 8 hereof relating to payments and redemption notices to
17 owners of the Bonds may be modified to comply with the policies and procedures of such
18 depository. The City will not have any responsibility or obligation to any purchaser of a
19 beneficial ownership interest in any Bonds or to any participants in such a depository with
20 respect to (i) the accuracy of any records maintained by such securities depository or any
21 participant therein; (ii) any notice that is permitted or required to be given to the owners of the
22 Bonds under this Resolution; (iii) the selection by such securities depository or any participant
23 therein of any person to receive payment in the event of a partial redemption of the Bonds;
24 (iv) the payment by such securities depository or any participant therein of any amount with
25 respect to the principal or redemption premium, if any, or interest due with respect to the Bonds;

1 (v) any consent given or other action taken by such securities depository as the owner of the
2 Bonds; or (vi) any other matter.

3 The City Treasurer is hereby also authorized and directed to appoint one or more agents
4 as he or she may deem necessary or desirable. To the extent permitted by applicable law and
5 under the supervision of the City Treasurer, such agents may serve as paying agent, fiscal
6 agent, or escrow agent or registrar for the Bonds or may assist the City Treasurer in performing
7 any or all of such functions and such other duties as the City Treasurer shall determine. Such
8 agents shall serve under such terms and conditions as the City Treasurer shall determine. The
9 City Treasurer may remove or replace agents appointed pursuant to this paragraph at any time.

10 Section 12. Defeasance Provisions. Payment of all or any portion of the Bonds may be
11 provided for prior to maturity by irrevocably depositing with the City Treasurer (or any
12 commercial bank or trust company designated by the City Treasurer to act as escrow agent with
13 respect thereto):

14 (a) An amount of cash equal to the principal amount of all of such Bonds or a

2 For purposes of this Section 12, "United States Obligations" shall mean direct and
3 general obligations of the United States of America, or obligations that are unconditionally

6 have been stripped by request to the Federal Reserve Bank of New York in book-entry form.

7 Section 13. Official Notice of Sale. The form of proposed Official Notice of Sale inviting
8 bids for the Bonds is hereby approved and adopted as the Official Notice of Sale inviting bids
9 for the Bonds with such changes, additions and completions as may be made in accordance

8 of the Bonds, or any portion thereof, or any other funds of the City, that would cause the

5 Section 17, the City covenants that it will comply with the provisions of the Tax Certificate to

7 time to time (herein called the "Tax Certificate"). These covenants shall survive payment in

14 revisions as may be determined to be necessary or desirable made in accordance with
15 Section 19 hereof. The Controller is hereby authorized and directed to enter into the Continuing
16 Disclosure Certificate on behalf of the City.

17 Section 19. Modification to Documents. Any City official authorized by this Resolution to
18 execute any document is hereby further authorized, in consultation with the City Attorney, to
19 approve and make such changes, additions, amendments or modifications to the document or
20 documents such official is authorized to execute as may be necessary or advisable (provided
21 that such changes, additions, amendments or modifications shall not authorize an aggregate
22 principal amount of Series 2000C Bonds in excess of \$6,180,000 or conflict with the provisions
23 of Section 4 hereof). The approval of any change, addition, amendment or modification to any
24 of the aforementioned documents shall be evidenced conclusively by the execution and delivery
25 of the document in question.

10 Section 23. Accountability Reports. The Series 2000C Bonds are subject to Article VIII
11 of Chapter 2 of the City's Administrative Code. Accountability report(s) with respect to the
12 Series 2000C Bonds shall be submitted at the time(s) and in the manner required by said Article
13 VIII.

14 Section 24. General Authority. The Clerk of the Board of Supervisors, the Finance
15 Committee of the Board of Supervisors, the Mayor, the City Treasurer, the Director of Public
16 Finance, the City Attorney and the Controller are each hereby authorized and directed in the
17 name and on behalf of the City to take any and all steps and to issue and deliver any and all
18 certificates, requisitions, agreements, notices, consents, and other documents, including but
19 not limited to letters of representations to any depository or depositories which they or any of
20 them might deem necessary or appropriate in order to consummate the lawful issuance, sale
21 and delivery of the Bonds.






