3 **Resolution approving a second amendment to the grant agreement between the City**
4 **and County of San Francisco and Wu Yee Children's Services for the provision of Early**
5 **Care and Education Integrated Services to support the City's implementation of the**
6 **San Francisco Citywide Plan For Early Care and Education, to extend the term up to**
7 **two years for a total term of July 1, 2017, to June 30, 2022, and to increase the grant**
8 **amount by \$36,251,054 resulting in a revised total grant amount of \$75,810,088 to**
9 **commence following Board approval.**

11 WHEREAS, The City and County of San Francisco, wishes to provide Early Care and
12 Education Integrated Services by delivering subsidy administration and resource and referral
13 services; and

14 WHEREAS, The Office of Early Care and Education, in partnership with the Human
15 Services Agency, conducted a Request for Proposals for these services in January 2017; and

16 WHEREAS, Wu Yee Children's Services submitted a responsive and responsible
17 proposal and was awarded the grant for the total amount of \$29,198,846 in February 2017 to
18 provide services for the period from July 1, 2017, through June 30, 2020; and

19 WHEREAS, An initial modification of the Wu Yee Children's Services grant in the
20 amount of \$7,440,303 resulting in a new total amount of \$39,559,034 was requested in April
21 2019; and

22 WHEREAS, The Human Services Agency Commission approved this initial
23 modification to the Wu Yee Children's Services grant at its meeting of April 25, 2019; and

24 WHEREAS, A second modification of the Wu Yee Children's Services grant, to extend
25 the grant from July 1, 2017, through June 30, 2022, in the amount of \$36,251,054 resulting in

a new total amount of \$75,810,088 was requested in November 2019; and

WHEREAS, The Human Services Agency Commission approved this second modification to the Wu Yee Children's Services grant at its meeting of November 21, 2019; now, therefore be it

RESOLVED, That the Board of Supervisors hereby approves the second modification of the grant with Wu Yee Children's Services in the amount of \$36,251,054, resulting in a revised total amount of \$75,810,088 for the period of July 1, 2017, to June 30, 2022; and, be it

FURTHER RESOLVED, That within thirty (30) days of the modification being fully executed by all parties, the Human Services Agency shall provide the final grant to the Clerk of the Board for inclusion into the official file.
