1 [Preparation of Findings Related to the Exemption Determination - 1100 Lombard Street]

2
3 **Motion directing the Clerk of the Board to prepare findings related to the appeal of the**
4 **exemption determination by the Planning Department that the project located at 1100**
5 **Lombard Street is exempt from environmental review.**

7 WHEREAS, On or about February 3, 2012, the Planning Department determined that a
8 proposal to create a new firewall on the 1100 Lombard Street property was exempt from
9 environmental review under the California Environmental Quality Act ("CEQA"), the CEQA
10 Guidelines and San Francisco Administrative Code Chapter 31 as a Class 1 categorical
11 exemption, a minor alteration to an existing structure (the "exemption determination"). By
12 letter to the Clerk of the Board dated March 20, 2012, Christa Shaw, on behalf of the John
13 Sperling Irrevocable Trust, owner of 2323 Hyde Street ("Appellant"), appealed the exemption
14 determination; and

15 WHEREAS, on May 1, 2012, this Board held a duly noticed public hearing to consider
16 the appeal of the exemption determination filed by Appellant, and following the public hearing
17 affirmed the exemption determination; and

18 WHEREAS, In reviewing the appeal of the exemption determination, this Board
19 reviewed and considered the exemption determination, the appeal letter, the responses to
20 concerns document that the Planning Department prepared, the other written records before
21 the Board of Supervisors and all of the public testimony made in support of and opposed to
22 the exemption determination appeal. Following the conclusion of the public hearing, the
23 Board of Supervisors affirmed the exemption determination for the Project based on the
24 written record before the Board of Supervisors as well as all of the testimony at the public
25 hearing in support of and opposed to the appeal. The written record and oral testimony in

1 support of and opposed to the appeal and deliberation of the oral and written testimony at the
2 public hearing before the Board of Supervisors by all parties and the public in support of and
3 opposed to the appeal of the exemption determination is in the Clerk of the Board of
4 Supervisors File No. 120262 and is incorporated in this motion as though set forth in its
5 entirety; now therefore be it

6 MOVED, That this Board of Supervisors directs the Clerk of the Board to prepare the
7 findings specifying the basis for its decision on the appeal of the exemption determination
8 issued by the Planning Department for the Project.
